

# **SDDOT NEWS**

### SDDOT Tentative 2019-2022 Statewide Transportation Improvement Plan (STIP)

In July, the SDDOT held public meetings in Aberdeen, Sioux Falls, Rapid City, Pierre and via



webinar to present the Tentative 2019-2022 STIP and to receive public input. The meetings began with SDDOT presentations pertaining to funding, the overall STIP development process and project updates. Key excerpts from the SDDOT presentation are shown below. Further details are available at <a href="https://www.sddot.com">www.sddot.com</a>.

- The current Federal Highway Bill (FAST ACT) expires on September 30, 2020. The FAST Act provides an anticipated \$310M annually for South Dakota. These funds are generated by the Federal Motor Fuel Tax (\$0.184/gallon for gasoline and \$0.244/gallon for diesel fuel). South Dakota is a "donee" state, receiving back over \$2 for every \$1 paid in to the federal government. Federal funds comprise a large part (70%) of SDDOT's construction budget.
- The State Highway Trust Fund provides an anticipated \$130M annually. The main revenue sources are the State Gas Tax (\$0.28/gallon) and 4% Motor Vehicle Excise Tax.
- The Tentative 2019-2022 STIP anticipated total funding is \$483M for 2019, compared to \$474M in 2018.
- Based on the Tentative 2019-2022 STIP, bridge condition will remain relatively constant but the pavement condition will decrease moderately over time.

The SD Transportation Commission will review the public comments and make changes to the STIP, if deemed necessary. The Commission will approve the final STIP at their September meeting. Once the STIP has been approved, the AGC will notify members and copies will be available on the SDDOT website.



### **AGC LEGAL MINUTE**

### Jason Smiley, AGC Legal Counsel



#### **CUTTING YOUR RISK**

Risk management is incredibly important to contractors, and there are many different kinds of risks to be considered. Those risks are both internal and external. When it comes to the management of legal risks, practical, actionable steps may be helpful. Advice is needed. What follows are ten actionable steps that can be implemented immediately.

### **TIP #1**

Identify problems early. Every business has disputes from time to time. Learning about issues early allows you to respond in a timely fashion so that you can either correct or mitigate the problem. To do this you need to encourage open communication with your work force. When unfortunate events take place, the last thing you want is reticent employees who are afraid to give you the bad news.

#### TIP #2

Manage staff appropriately. It doesn't do any good to have a system in place to identify problems if you have the wrong people responding to the problems once identified. Indeed, this can exacerbate the issue by making the other party feel ignored, insulted, etc.

#### **TIP #3**

Document everything. Memories fade with time, and some issues do not become apparent until long after the events that precipitated them. In such a situation, the party with the best documentation is in a much better position should it come to formal proceedings.

#### **TIP #4**

Read and understand everything. It is no defense to a claim of breach of contract that you didn't really understand the deal.

#### TIP #5

Hire professionals. You can't be an expert at everything. If you don't understand the transaction being proposed, hire someone to assist you.

#### **TIP #6**

Consider a business solution. When disputes arise between ongoing business relations, it may make little sense to throw the baby out with the bath water. Consider how to make up the losses as part of the ongoing relationship.

### TIP #7

Don't dabble. Do what you are good at and avoid undertaking responsibilities beyond your expertise.



#### **TIP #8**

Don't date the staff. This much-ignored advice is one of the leading causes of lawsuits by employees when the personal relationship sours.

#### TIP #9

If it is too good to be true, it probably is. Many disputes arise as a result of a lack of due diligence. Almost all of them could be avoided by a little investigation.

#### **TIP #10**

Follow the Golden Rule. Treating people the way that you want to be treated will help you avoid disputes of every kind and lawsuits in particular.

### **LEGISLATIVE NEWS**

General Election Ballot Information for Members AGC offers this synopsis of constitutional amendments and initiated measures that will be on the November 2018 ballot so our members can be informed voters.

- Constitutional Amendment W: An initiated amendment to the South Dakota Constitution changing campaign finance and lobbying laws, creating a government accountability board, and changing certain initiative and referendum provisions. AGC's Government Affairs Committee has voted to oppose W for these reasons:
  - Highjacks state constitution
  - Creates a 7-member State Accountability Board, that oversees all non-federal elected officials. The board accepts anonymous complaints and is accountable to no one. The Board would be funded by a \$389,000 annual appropriation from the state general fund (increases with inflation).
  - Reduces the amount that can be given to candidates and eliminates corporate campaign giving.
  - Attempts to regulate lobbyists and lobbyist activities.

AGC urges you to VOTE NO ON W.

- Constitutional Amendment X (SJR 1): An amendment to the Constitution of the State of South Dakota requiring 55% voter approval to adopt an amendment to the Constitution. The state constitution currently requires a majority vote, 50% plus 1%.
- Constitutional Amendment Z (HJR 1006): An amendment to the Constitution of the State of South Dakota, requiring proposed amendments to the Constitution to pertain to one subject. This is in response to previous constitutional amendments that contained multiple sections and covered several topics.
- Initiated Measure 24: An initiated measure
  prohibiting contributions to ballot question
  committees by non-residents, out-of-state political
  committees, and entities that are not filed with the
  Secretary of State.
- Initiated Measure 25: An initiated measure increasing the State tobacco tax and creating a postsecondary technical institute fund for the purposes of lowering student tuition and providing financial support to the State postsecondary technical institutes. AGC's Government Affairs

Committee is still analyzing the potential impact of this measure to current tech school funding, and has taken no position until that analysis is complete.

they have supported the construction industry and/or business in the past or were recognized as business-friendly candidates. CONPAC members have been hand-delivering campaign contributions so that they can spend some time with the candidates and share information about the construction industry with them. This is a big effort and comes during the busiest time of the year for contractors but establishing relationships with candidates pays off during legislative session. ### Average South Dakota Workers' Compensation Rates Decreasing for 7th Consecutive Year

Effective July 1, 2018, the South Dakota Division of Insurance approved a seven percent reduction in the SD workers' compensation rates (loss costs). This is the seventh consecutive year that the average workers' compensation rate had decreased in the state and totals a thirty percent average decrease over that same time frame. Remember that this is an average decrease across nearly 600 classifications. Individual classification rate changes can vary by as much as 15%. That means the rate for your specific business could increase 8% or decrease 22%. These rates are calculated by a company named the National Council on Compensation Insurance (NCCI). Their actuaries calculate these rates using a complicated formula that takes into consideration the number of claims (frequency) and the cost of those claims (severity), among many other factors. The rates were approved by the Workers' Compensation Advisory Council.



### President Signs Workforce Executive Order - AGC Participates in White House Event to Sign Job

In July, the President signed an Executive Order that establishes the President's National Council for the America Worker. The council will help



develop a national strategy for job training programs with guidance from an advisory board of private sector and government representatives to help ensure the programs being taught in classrooms and workplaces are needed.

The EO also included a pledge by companies and associations to educate, train and upskill workers through apprenticeships and on-the-job training. AGC was among organizations signing the pledge through our existing AGC chapter training programs, AGC of America safety training and our other training programs.



# Trump Administration Expands Steel & Aluminum Tariffs - AGC Provides Tariff Resources for Construction Contractors

In late May, U.S. Department of Commerce Secretary Wilbur Ross announced steel and aluminum tariffs for Canada, Mexico and the European Union effective June 1. These countries were previously spared from the March 23-imposed 25 percent tariff on steel and 10 percent tariff on aluminum. According to reports, at least 30 percent of imported steel came from these nations in 2017. As a result, contractors may expect further increases in domestic steel prices and mill delivery delays. AGC has put together several resources for construction contractors regarding the various trade actions affecting construction, including a primer on tariffs in effect or under consideration, and contractual considerations private and federal/federal-aid contractors should consider in light of the tariffs.

Construction contractors are encouraged to contact the president and their congressional elected officials to let them know how these tariffs impact their construction markets. AGC continues to educate the White House and Congress on the impacts these and other potential tariff actions are having on the construction industry.

Some of the ideas have come from existing proposals from the administration's infrastructure plan as well as members of Congress from both parties. Many of the plan's elements have long-been supported by AGC. To help build support for the Shuster plan, please contact your Representative and ask them to support Chairman Shuster's effort and act on an infrastructure bill. Shuster said the intent of the proposal is to reignite the infrastructure conversation with the hope that infrastructure legislation will be released in the next Congress. Shuster is retiring from Congress at the end of this year.

The AGC of America PAC recently made a campaign contribution of \$2,500 to U.S. House of Representatives Candidate Dusty Johnson (R). 
